SUBJECT: Abandoned Pipe Beneath RD 536 Levee

Dear Mr. Barton:

Westervelt Ecological Services (Westervelt) referred your letter dated February 22, 2024, regarding the subject matter to the staff of Reclamation District (RD) 2084 for review and a response.

The subject facility comprised of multiple pumps and discharge pipes through the RD 536 levee appears to supply water from a slough in RD 2084 to the benefit of lands in RD 536. We researched historic files and inspection reports from the US Army Corps of Engineers (USACE), California Department of Water Resources (DWR), Central Valley Flood Protection Board (CVFPB), and our own records regarding this facility. In no case did we find any record of RD 2084 or Westervelt owning, permitting, approving, or operating the facility.

RD 2084 and Westervelt support proper abandonment of the levee penetration by RD 536 or the permitted owner of the encroachment. Both are also willing to support any immediate temporary actions necessary to protect against the uncontrolled flow of water into RD 536, including temporary property access.
